CONCESSIONAIRE AGREEMENT

THIS AGREEMENT is made and entered into between **TC Sunrise Rotary/Charity**, a Washington nonprofit corporation and tax-exempt organization under section 501(c)(3) of the Internal Revenue Code ("**See3Slam**"), and the **Concessionaire** listed below, for the **2019 See3Slam 3-on-3 Tournament Weekend Experience** held at the John Dam Plaza, in Richland, Washington.

WHEREAS, said **Concessionaire** desires to be a vendor at the 2019 See3Slam 3-on-3 Tournament Weekend Experience, taking place July 12 through July 14, 2019.

WHEREAS, **See3Slam** desires to have said Concessionaire as a vendor at the 2019 See3Slam 3-on-3 Tournament Weekend Experience.

Now, **THEREFORE**, it is agreed as follows:

Concessionaire shall for the Contract Year 2019:

- Show proof of City of Richland business license and insurance
- Provide notification of desired start and end times per event schedule
- Submit \$200 check made payable to TC Sunrise Rotary/Charity by June 1, 2019
- Provide photo of your set up, business logo in jpeg format
- Identify power/water/location requirements and estimated size of your footprint
- Optional: Contribute a charitable donation from your weekend's proceeds to support Rotary efforts.

Additionally, the following applies for Concessionaire's designated as food vendors:

- Show proof of current Benton Franklin Health Permit and photo menu offerings
- Sell only Coca-Cola Products supplied to you for purchase on site (cash or check)
- Sell provided Dasani water for \$1 each for pass through to TC Sunrise Rotary

See3Slam shall for the Contract Year 2019:

- Grant concessionaire permission to occupy John Dam Plaza from July 12 through July 14, 2019
- Grant non-exclusive rights to operate as a concessionaire and place a trailer or tent/kiosk in John Dam Plaza, and provide accessible power and water as requested.

Special Conditions. The following conditions shall be honored by Concessionaire at all times during the hours of operation.

- No signs are allowed in the park or on City right-of-way unless permitted by the City’s Development Services Office and the Parks & Public Facilities Department.
- Concessionaire shall not solicit customers from outside the structure. Music, loud noises, lights, or other similar gimmicks shall not be used to solicit customers.
- All waste generated from the business shall be deposited in the dumpster made available in the parking lot. Garbage will be removed from the provided garbage cans once per day. Concessionaire is responsible for any additional garbage containers and pick-up outside standard maintenance. Concessionaire is responsible for additional garbage bags to manage excessive garbage and properly place for pickup by dumpster.
- If operating as a designated food vendor, Concessionaire shall acquire all necessary health department permits related to selling and distributing food and beverage products.
- Concessionaire shall not engage in the rental of any merchandise or engage in any other business activity in or on the premises outside the scope of this Agreement.
- Wastewater, grease and other cooking by-products shall not be disposed of in city-owned garbage cans and must be removed offsite for proper disposal. Proper measures must be taken to protect concrete from cooking damage.
